#### **Incident Response to Terrorist Bombings - 4 hours**

***This class will cover numerous topics to prepare them to respond to Terrorist Bombing Incidents. At the conclusion of the class the student will be able to:***

Summarize potential targets, tactics, and indicators associated with terrorist attacks involving explosives and incendiaries. To include: Identifying potential terrorist targets within our communities, major categories of terrorist groups, including their preferred tactics/targets, and common pre-attack indicators

Recognize explosive and incendiary materials, devices, and device components. To Include: Categories of readily available explosives, initiators, and blasting caps and recognize their common forms, indications that a bomb could be initiated, identify possible "booby-traps" and/or concealed devices, and common characteristics of improvised explosive device (IED) packaging and concealment.

List basic hazards presented by the presence of explosives (including the threat of secondary devices), calculate recommended safe distances to isolate the incident scene, and recall notification procedures common to many emergency response plans and relate them to hazards presented by actual or potential explosive incidents. To include: Priority actions, safety considerations, and the Awareness Level response required when responding to bomb threat incidents, safety considerations when responding to an actual or potentially explosive incident, principles to avoid the hazards of an explosive incident, and determine safe evacuation distances as identified in the

BATFE chart. In addition: important considerations for first responders and hazards typically encountered in structures after a bombing incident, body injuries associated with an explosive blast, hot, warm, and cold zones when establishing a perimeter, and common components of a notification protocol.

### **Prevention and Response to Suicide Bombing Incidents - 3 hours**

***This class will cover numerous topics to prepare them to attempt to Prevent and Respond to Suicide Bombing Incidents. At the conclusion of the class the student will be able to:***

Identify various definitions relating to terrorism, suicide terrorism and terrorist organizations; a historic overview of suicide bombings and terrorist groups that utilize suicide bombing as a tactic; the evolution of the use of suicide bombings; the three types of suicide bombings; likely targets of suicide bombings; the nine phases of a suicide bombing attack; characteristics and psychological aspects of suicide bomber; catalysts that move terrorist groups and their people to carry out suicide bombings; and, how emergency organizations can disrupt a terrorist cell's ability to carry out a suicide bombing.

Provided information to allow them to identify and discuss common sources of counter-terrorist protective information and to recognize common pre-attack indicators as they relate to the nine phases of a suicide bombing attack.

Provided information on recognizing minimum evacuation distances and using pre- and post-blast personal protection. Including minimum evacuation distances related to the three types of suicide bomb devices.
